The Board of Oikocredit announced that Ms. Rosalind Copisarow will no longer continue her position as Managing Director (MD) of Oikocredit Ecumenical Cooperative Society as per 1 January 2012. In the meantime the Board of Directors of Oikocredit has delegated the responsibility of managing Oikocredit to the Management Team, under the leadership of the Deputy Managing Director, Mr. Bernardus Henricus Johannes Simmes, as referred to on page 36 of the Oikocredit Ecumenical Development Cooperative Society Prospectus (incorporated by reference in the Prospectus).
